### RENEWAL/DETERMINATION OF LEASE IN RESPECT OF SURVEY NO.322-708A, HOUSE NO.51, MAHAL No.5, WARD NO.03, SADAR BAZAR, DANAPUR CANTONMENT

It is brought to the notice of the Board that Government of India, Ministry of Defence circulated a policy vide letter No.11013/2/2016/D(Lands) dated 10.03.2017 and the applicability extended upto 31.12.2019 vide letter No.11013/2/2016/D(Lands) dated 31.12.2018 regarding:

- 1. Extension of expired/expiring Cantonment Code Leases of 1899 &1912 and Cantonment Land Administration Rules, 1925 & 1937
- 2. Renewal of Cantonment Code and CLAR leases whose full term has not expired

1. It is to intimate that initially a lease dated 24.06.1932 measuring an area 417sqft. and another lease dated 02.01.1933 measuring an area 19sqft. was granted to Ulfat Hussain S/o Huigan Mian under Schedule VI CLAR1925 (copy of Lease Indentures enclosed). Later on, the above said two leases was surrendered and amalgamation of site measuring 19sqft into 417 sqft. comprising Survey No.322-708A has been occurred and a fresh lease of land measuring 436sqft. for residential purposes was granted to Shri Ram Rattan Prasad Vidyarathi in Schedule VIII of CLA Rules 1937 for 30 years (renewable for further term of 30years at the option of the lessee) w.e.f. 24.06.1961 on payment of an annual lease rent of ₹8.00. The copy of letter No.718/60/L/L&C/72 dated 07.05.1973 to sanction for grant of fresh lease on Schedule VIII of CLA Rules 1937 is enclosed herewith. But the lease indenture of lease under Schedule VIII of CLA Rules 1937 is not available to this office.

 On expiry of the 1<sup>st</sup> term of lease, the lease was renewed for the second term of 30 years w.e.f. 24.06.1961 as per Para (c) of ML&C Dte letter No.718/60/L/L&C/72 dated 07.05.1973.

Accordingly to GLR, The first recorded entry is for area measuring 436sqft. HOR/lessee is in the name of Ulfat Hussain and nature in lease on schedule VI of CLA Rules 1925.(Copy Enclosed)

- According to 2<sup>nd</sup> /final, the recorded HOR/lessee is Shri Ram Rattan Prasad Vidyare i for the area 436sqft. held on lease under Schedule VIII of CLA Rules 1937 for 30 years w.e.f. 24.06.1961 for residential purposes (copy enclosed).
- 4. The applicants namely, Rajeev Ranjan Prasad and Priya Ranjan Prasad are not recorded lessee. The applicants occupied the property on inheritance ground. As per notarized affidavit, after death of the lessee, Ram Rattan Prasad Vidyarathi and his wife, Lilawati Devi, the property came into possession of their six sons, namely, 1. Rewati Raman Prasad Neelam, 2. Radhika Raman Prasad 3. Rajeev Ranjan Prasad, 4. Priya Ranjan Prasad, 5. Satya Ranjan Prasad & 6. Ramesh Ranjan Prasad.
  - (i) The first son, Shri Rewati Raman Prasad Neelam given his share to other five brothers through deed of sale dated 17.02.1984 (copy enclosed)
    - (ii) Then other two brothers, Satya Ranjan Prasad & Ramesh Ranjan Prasad had given their share to Rajeev Ranjan Prasad. A copy of notarized affidavit signed by both transferors of the share has been produced by the applicant (copy enclosed).

- (iii) One of the share held by Radhika Raman Prasad was given to Priya Ranjan Prasad vide sale deed dated 31.07.2005 executed by Santoshi Devi W/o Late Radhika Raman Prasad (copy enclosed).
- (iv) Thus the whole property came into possession of Rajeev Ranjan Prasad and Priya Ranjan Prasad. They are living in the property with their family.
- 5. The site is granted for the purpose of residential purpose. As per the site inspection report, the property is being used for residential purposes. Hence there is no chance of purpose involved on the site.
- As per condition III of the lease deed, the lease rent payable for the under mentioned period is worked out to Rs.585/-.
  - (i) Period from 24.06.1961 to 23.06.1991 @ ₹8.00 is worked out to ₹240.00

(ii) Period from 24.06.1991 to 23.03.2020 @ ₹12 is worked out to ₹345.00

It is brought to the notice of the Board that Government of India, Ministry of Defence circulated a policy vide letter No.11013/2/2016/D (Lands) dated 10.03.2017 regarding:

- Extension of expired/expiring Cantonment Code Leases of 1899 &1912 and Cantonment Land Administration Rules, 1925 & 1937
   Renewal of Cantonment Code and CLAP leases
- . Renewal of Cantonment Code and CLAR leases whose full term has not expired

The brief of the case is furnished as under:

 The site located in civil area, comprising Survey No.322-1113, Sadar Bazar, Danapur Cantt admeasuring area 435sqft. was initially granted to Kalyan Sao S/o Khooba Sao on 25.11.1930 for the purpose of Shop in Schedule VI CLAR 1925 for a term of thirty years w.e.f. 17.09.1930 on payment of lease rent of ₹7/12/- per annum, classified as B3 land and under the management of Cantonment Board, Danapur.

The said lease Sy.No.322-1113 was surrendered on 13.05.1947 to Cantonment Board, Danapur. Subsequently Sy.No.322-1113 was leased to Bihari Sao S/o Bhagwan Dass on 19.04.1947 for the purpose of 'dwelling house and platform' in Schedule VIII CLA Rules 1937 for a term of fourteen years two months twenty six days renewable at option of lessee up to ninety years w.e.f. 21.06.1946 for period of fourteen years two months twenty six days on payment of lease rent of ₹10/5/- (Rupees ten and five annas only) per annum. The 1<sup>st</sup> term of the lease was expired on 16.09.1960.

- 2. On expiry of the first term of lease on 16.09.1960, the lease was renewed for the second term of 30 years w.e.f. 17.09.1960 subject to execution of an amending deed for showing the purpose from 'dwelling house and platform' to 'Shop and platform', sanctioned vide HQ. Central Command (ML&C) letter No.17931-LC2 dated 08.11.1969 on payment of enhanced lease rent of ₹15.47 per annum. The purpose of the lease was changed from 'Dwelling house & platform' to 'Shop and platform'. But the execution of renewal of lease for 2<sup>nd</sup> term under Schedule IV of CLA Rules 1937 is not available in the office record. Hence the GLR could not be updated in respect of renewal of lease for the 2<sup>nd</sup> term. The 2<sup>nd</sup> term of lease was expired on 16.09.1990. The lease will be fully expired on 16.09.2020 without renewal proceeding due to non-submission of willingness with requisite documents by the occupiers. In this regard, a notice was issued to the occupiers vide this office letter No.CBD/Sy.No.322-1113/1195 dated 04.12.2019. Thereafter an option dated 20.12.2019 jointly by all the occupiers claiming the property was received for renewal of the property to this office on 21.12.2019.
- As per GLR, the said property comprising Survey No.322-1113, is leased in Schedule VIII in the name of Sri Kedar Nath & Smt. Manki Devi 'for construction of Shop and Platform' at the lease rent of ₹10.31 per

annum, classified as B3 land under the management of Cantonment Board. The 2<sup>nd</sup> term of lease was expired on 24.11.1960.

4. An application dated 20.12.2019, was submitted by Deepak Kumar Gupta, Dinesh Kumar (both sons of Jagarnath Prasad) and Aman Kumar S/o Late Amarnath Prasad, stating that the said property came in possession of him as share of ancestral property through family partition settlement among the successors of Kedar Nath and Manki Devi. From perusal of the deed, it is found that Manki Devi devaluated the property vide family settlement notarized dated 30.04.2011 in which the leased property was given in favour of her grandsons, Deepak Kumar Gupta & Dinesh Kumar, both sons of Jagarnath Prasad and Aman Kumar S/o Late Amarnath Prasad as contained in (Schedule-'\pi') कंडिका '\pi' and (Schedule-'\pi') कंडिका '\pi' of the settlement deed.

5. The site is granted for the purpose of 'for construction of Shop and Platform'. The site is currently used for running a Shop. Hence there is no change of purpose involved on the site.

### विषय / Subject: छावनी निधि से सड़कों का मरम्मत व रख-रखाव / REPAIR AND MAINTENANCE OF CANTT FUND ROADS

संदर्भ / Reference :सी.बी.आर. सं० 102 दिनांक 26.07.2019 और ए.एस.जी. श्री एस.डी.संजय, पटना उच्च न्यायालय द्वारा सुझाव दिया गया कानुनी राय CBR No.102 dated 26.07.2019 and legal opinion suggested by ASG, Sh S.D. Sanjay, Patna High Court.

बोर्ड के ध्यान में यह लाया जाता है कि विषय वस्तु छावनी निधि द्वारा मरम्मत और रखरखाव के लिए निविदा 28. 08.2019 को सी.पी.पी.पी. पर मंगाई गई थी। इससे पहले समान विषय निविदा दो समय बिंदुओं के लिए मंगाई गई थी। It is brought to the notice of the Board that the tender for the subject matter 'Repair and maintenance of Cantt Fund Roads' was floated on 28.08.2019 on CPPP. Earlier the same tender was floated two times.

For the time e-tender was floated on 13.02.2019, two bids were received, a legal opinion in the matter was taken in which it has been opined that " Upon Evaluation of the Technical Bid of the Tenderers the second Bidder could not be found eligible and only the bid of first bidder, namely, Vishal Enterprises, has been found to be valid as per tender requirement. In my view, this becomes a case of single tender. However, in the matter of tendering all the government organizations must maintain transparency. Although the General Financial Rules of the Ministry of Finance has provided for Award of the work even in the case of single offer, subject to the condition that the work is of urgent nature and in spite of more than one attempt only one bidder could found to be technically qualified. But in the

present case, the work is not of emergent nature and some delay will not cause much harm. It is always in the interest of the of the organization that there are more number o tenderers which will provide more competition. The work can wait for another few months if a fresh tender is invited for keeping transparency in it. MoD ID No.2(2)/2018-D(Q&C) दिनांक 05.11.2019 के संदर्भ में निर्देश दिया गया है कि सभी छावनी बोर्ड अपने क्षेत्रों में बहुस्तरीय कार पार्किंग की भूमि और अन्य आवश्यकताओं का पता लगाएंगे और बोर्ड के समक्ष प्रस्ताव रखेंगे। उन्होंने यह भी सुझाव दिया है कि भूमि उपलब्धता, छावनी का स्थान, आबादी की सीमा, बोर्ड की वित्तीय स्थिति और बोर्ड के लिए उपयुक्तता / बहुस्तरीय कार पार्किंग योजना की आवश्यकता, कार पार्किंग के प्रस्तावित स्थान आदि जैसे निर्देशों का निर्देश डीजीडीई को दिया गया था। डीजीडीई पत्र क्रमांक सं0 ७६/६७/एक्सपर्टसमिति/सी/डे/२०१/ 67/वोल –२ दिनांक ०७.११.२०१६ यह भी सलाह दी गई है कि कैंटोनमेंट बोर्ड, पुणे द्वारा कार्यान्वयन के तहत मल्टीलेवल कार पार्किंग परियोजना को मार्गदर्शन के उद्देश्य के लिए बोर्ड द्वारा एक मॉडल के रूप में माना जा सकता है। छावनी बोर्डों को यह भी सलाह दी गई कि गैर-यंत्रीकृत रैंप आधारित मॉडल पर विचार किया जा सकता है जिसके लिए सीईओ / कैंटोनमेंट बोर्ड, दिल्ली से इनपुट के लिए संपर्क किया जा सकता है। Reference to MoD ID No.2(2)/2018-D(Q&C) dated 05.11.2019 have instructed the all Cantonment Boards shall explore the land and other requirements of multilevel car parking in their areas and place the proposal before the Board. They have also suggested that parameters like land availability, location of Cantonment, population to be catered, financial position of the Board and suitability/requirement of Multilevel Car Parking scheme to the Board, proposed location of car parking etc. The instructions were communicated vide DGDE letter No.76/67/ExpertCommittee/C/DE/2018Vol-II dated 07.11.2019. It has also further been advised that the Multilevel Car Parking project under implementation by Cantonment Board, Pune may be considered as a model by the Boards for the purpose of guidance. The Cantonment Boards were also advised that nonmechanised Ramp Based Model may be considered for which CEO/Cantonment Board, Delhi can be contacted for input.

बोर्ड के संज्ञान में यह बात सामने आई है कि क्षेत्र में मार्शल और सदर बाजार की मौजूदगी के कारण वार्ड 1, 3 और 4 के आसपास के इलाकों में भी ट्रैफिक और लोगों की भारी आवाजाही है, और देवनिया नाला से गुजरने वाली सड़क भी बाजार क्षेत्र के माध्यम से मुख्य संपर्क लिंक दानापुर— गांधी मैदान—बांकीपुर रोड है। इन कारकों के परिणामस्वरूप यह पाया गया है कि सड़कों को वाहनों और पैदल चलने वालों के साथ सबसे अधिक समय तक चोक किया जाता है। सिविल प्रशासन ने कई बार बैठकों में और अनौपचारिक प्लेटफार्मों में कैंटोनमेंट बोर्ड/सीईओ को सुझाव दिया है कि वे आधुनिक पार्किंग सुविधा बनाने या मौजूदा पार्किगों को फिर से व्यवस्थित करने के द्वारा यातायात की भीड़ को कम करने के लिए आवश्यक कदम उठाएं। It is hereby brought to the notice of the Board that there is a huge movement of traffic and people in areas encompassing Ward 1,3 and 4, due to the presence of Marshall and Sadar Bazar in the area and also the road from Devania Nala passing through market area is the main connecting link Danapur- Gandhi Maidan-Bankipur Road. As a result of these factors it is found that the roads are most times choked up with vehicles and pedestrians. The civil administration has also many times in meetings and in informal platforms suggested/requested to Cantonment Board/CEO to take necessary steps to alleviate the traffic congestation by way of creating modern parking facility or re-organizing existing parkings.

वर्तमान में कार्यालय ई–टेंडर के माध्यम से आउटसोर्सिंग करके टैक्सी–टेंपो जीप और बस मैक्सी पार्किंग शुल्क से राजस्व उत्पन्न कर रहा है, जिसके लिए सर्वेक्षण संख्या 24 में एक क्षेत्र को मापने के लिए 0.587 एकड़ का उपयोग कैंटोनमेंट हैकनी कैरिज और मोटर लॉरीज़ स्टैंड के लिए किया जा रहा है। यह भी उल्लेख किया जा सकता है कि रिकॉर्ड सर्वे नंबर .292 के अनुसार रिक्त भूमि जीएलआर .224 (यानी सड़क बीच में चल रही है) के विपरीत है और अक्सर स्नैक्स और टिन स्टॉल आदि के विक्रेताओं द्वारा अस्थायी रूप से अतिक्रमण किया जाता है। जीएलआर सर्वे सं0 .292 में 0.914 एकड़ जमीन है और यह कैंटोमेंट बोर्ड के प्रबंधन के अधीन एक खाली भूमि है, जो सर्वे सं0 290–1 के समीपवर्ती खाली क्षेत्र को 2331sqft. मापती है। कैंटोनमेंट बोर्ड के प्रबंधन के तहत खाली भूमि भी है। Currently the office is generating revenue from Taxi-Tempo Jeep & Bus Maxi parking fee by outsourcing through e-tender for which space in Survey No.224 measuring an area 0.587 acres is being used for Cantonment Hackney Carriage and Motor Lorries Stand. It may also be mentioned that the vacant land as per GLR record Survey No.292 is opposite to Sy.No.224 (i.e. road is running in between) and is often encroached temporarily by vendors of snacks and Tin Stalls etc. As per entry in GLR Sy.No.292 is 0.914 acres and is a vacant land under management of Cantonment Board adjacent vacant area of Sy.No.290-1 measuring 2331sqft. is also vacant land under the management of Cantonment Board.

As a preventive measure against COVID-19 the Govt. has imposed a lockdown nationwide till may 17. The Cantonment Board as a municipal body during lockdown has also been in the frontline of the fight against COVID-19 by esnsuring proper sanitization, disinfection of public places, provding meals to destitute, workers and Covid warriors. As is known to all with regard to maintaining social distancing, declaration of containment zones, opeiing of Bazar and shops are as per the directive of the concerned State Govt. under the framework guideline provided by the Central Government.

Now, in the post-lockdown scenario with certain relaxation on economic activities due care and preventive measures will have to be implement by each local authorities to ensure that there is no rapid spread of COVID-19 infection. Therefore the Board to discuss and suggest the road map/post lockdown measures to be taken by Danapur Cantonment Board.
