Sub: AMENDMENTS PROPOSED IN DRAFT BUSINESS REGULATIONS

Reference to Directorate General, Defence Estates, Govt. of India, Ministry of Defence, Raksha Sampada Bhawan, Ulaanbaatar Marg, Delhi Cantt letter No. 29/Business Regulation/C/DE/2021 dated 03 Feb, 2021, it was directed that: "

(i) To constitute three more Committee viz, the Finance Committee, the Education Committee and the Health & Environment Committee unde section 48(e) of the Cantonments, Act, 2006 and also advise all the Cantonment Boards to suitably amend their business regulations for constitution of said Committees consistent with the Composition, and delegate roles & responsibilities and functions suggested by the Government. The roles and responsibilities assigned should include those indicated in Annexure-B. In addition, any other suitable roles and responsibilities may be assigned, if felt necessary.

In the event of Boards having a Committee which has overlapping functions as mentioned in Annexure-B, the functions & nomenclature of those committees may be suitably amended to align with the above said Committees.

 (ii) Civil Area Committee may be empowered to exercise the powers, duties and functions of the Board as required under section137(2) (the Board to take such measures as are necessary in

its opinion for for preservation of breeding of mosquitoes, insects of any bacterial or viral carries of disease in public places under the Board), Section 151 (Permission for use of new burial or burning ground), Section 168 (Disinfecton of buildings or articles therein), Section 169 (Destruction of infectious hut or shed) & Section 170 (Temporary Shelter for inmates of disinfected or destroyed building or shed).

- (iii)Cantonment Boards may through a resolution, delegate the functions provided under section 353 of the Cantonments Act, 2006 to the Vice-President of the respective Boards, as deemed appropriate.
- (iv) In class I, II & III Cantonment Boards, except the Vice-President, no other elected member should be nominated to more than two of the Committees.
- 3. This Dte Gen, Vide letter under reference, forwarded the instructions of the MoD to the Directorates, DE, and the Cantonment Boards, and it was directed that proposals for approval of the draft Business Regulations, amended as per the directions issued, may be submitted for approval of Central Government and publication thereafter.
- 4. The draft Business Regulations received from Cantonment Boards have been examined. It is observed that the Cantonment Boards have constituted the three committees and have empowered them by assigning the duties and responsibilities of the Board, as suggested in the MoD letter dated 23.12.2019. However, it is observed that the Boards have resolved that the committees will be recommendatory in nature and will require confirmation by the Boards. Thus, the proposed amendments of Business Regulations are not in consonance with MoD letter ibid.

In view of the above, the Cantonment Boards may be directed to revisit/reconsider the matter in the light of guidelines by the MoD vide letter dated 23.12.2019. It was directed to forward the mended business regulations by 08.02.2021 and in pursuance of the instruction the same is placed before the Board."

II. Also in draft Business Regulations of Class I, II & III Cantonment Board, the following provisions has not been incorporated by Cantt Board and the following provisions may be added in new para No.23.

" In class I, II & III Cantonment Boards, except the Vice-President, no other Elected Member should be nominated to more than two of the committees."

All the relevant documents/papers are placed on the table. The Board may consider the same and approve accordingly.

RESOLUTION: The Board considered all the relevant documents, guidelines issued by MoD and discussed

the matter at length. The Board noted that in draft Business Regulation, CAC has already been empowered under regulation 19 of (iv) (e), so the Board resolved to maintain this provision as it is. The Board also resolved to include point No.03 of agenda side i.e. **"Except the Vice President, no other Elected Member should be nominated to more than two of the committees"** in Draft Business Regulation in new para No.23. The Board further discussed various provisions of 353 of Cantonments Act, 2006 in which PCB commented that there is already a provision under Section 21 (2) of the cantonments Act where in it is mentioned that "The President may, by order in writing, empower the Vice President to execrcise all or any of the powers and duties refereed to in clause (b) of Subsection (1) other than any power, duty or function which he is by resolution of the board expressly forbidden to delegate.PCB also commented & recommended that for transparency, to avoid Arbitrariness and for bringing objectivity into the decisions and

functioning of the Board, functions provided under section 353 of the Cantonments Act, 2006 shall not be delegated to the Vice President only. Hence the board discussed & resolved not to delegate functions under various provisions of 353 of Cantonments Act, 2006 including clause(b) of sub-section (5) of Section 290 and section 167 to Vice President of Catnonment Board. The Board also noted the DGDE observations regarding recommendatory nature of 03 committees i.e. Finance Committee, Health and Environment Committee and Education Committee and PCB commented & recommended that Regulation No.20(xi), Regulation No. 21(xi) & Regulation No. 22(xi) shall be kept as it is and the decisions of the respective committee on Regulation No.20(xi), Regulation No. 21(xi) & Regulation No. 22(xi) shall be placed before the board at its next meeting for confirmation as the same is in consonance with the Cantonments Act, 2006 & help in maintaining check & balance in the functioning of the Cantonment Board in a transparent manner & avoids Arbitrariness and brings objectivity in the decisions/resolutions of the Board.Hence the board considered and approved to keep the Regulation No.20(xi), Regulation No. 21(xi) & Regulation No. 22(xi) as it is, as passed earlier in the Board.

The Board considered and approved the Draft Business Regulations after incorporating the above and the same may be forwarded to the higher authority for publication in Gazette notification.
