

Considered and approved the rate of Rs. 1,31,00,400/- per annum "For Awarding the rights to collect the License Fee on entry of commercial vehicles at he pre-designated entry points in Danapur Cantonment" quoted by Rajendra Singh as reasonable and highest (H1) and tender for "For awarding the rights to collect the License Fee on entry of commercial vehicles at the pre-designated entry points in Danapur Cantonment" is hereby given/awarded to Rajendra Singh (being H1) for the period of one year w.e.f. 01.10.2019.

While noting the circular Agenda on 18.10.2019, Shri Ranjeet Kumar, Elected member along with Shri Nawal Kishor Prasad requested the board to Cancel the tender as survey should be conducted before the starting of the tender process, terms and conditions to be decided by the elected members and why Shri Rajender singh was given the tender last year also. Others Elected members also participated in the discussions. Adm Comd. told that the contract was done through e tender through e procurement website of Government of India and once the contract is awarded, the contract agreement becomes legal document and the same cannot be cancelled. President Cantonment also commented that unless there is major observation or complaint from the bidders, the tender cannot be cancelled. However, Shri Ranjeet Kumar produced one complaint letter from Shri Pintu Kumar supposedly, an employee of the contractor Rajendra Singh regarding EPF, ESIC payment etc. To this, Member secretary apprised the Board that legal opinion on the Tender has been taken from Additional Solicitor General of India at Patna High Court and he has provided following legal opinion

Thus, all that which was required by the Cantonment Board for awarding the contract to the highest bidder consequent upon the process of bidding has been completed and a valid contract has come into existence between the Board and the said Contractor, namely, Sri Indra Singh. It appears that a complaint has been sent in writing by one Pintu Kumar addressed to the President, Cantonment Board, Danapur with a copy to the Hon'ble Chief Justice, Patna High Court, Chief Executive Officer, Cantonment Board, Danapur and some other officials, like the Assistant Labour Commissioner, Central Patna, the P.F. Commissioner, New Delhi and E.S.I. Commissioner, Patna alleging there in violation of provisions of Minimum Wages Act and non payment of certain dues of the workers. The said Pintu Kumar claims to be working with the Contractor. So far the allegation of violation of provisions of different statutes is concerned, it is for those departments to entertain the complaint and to enquire if they found prima facie allegation to be correct and then to initiate proceeding and take action against an employer. The present contract has got no bearing with the above complaint and the Cantonment Board, Danapur cannot take cognizance of these complaints. The said Pintu Kumar is obliged under law to approach the statutory authorities under which he has made the complaint, with regard to this grievances raised in his Complaint Petition. The complaint can in no manner affect the validity of the Contract. I opine accordingly."

Shri Naval Kishore, Elected member commented that legal opinion is taken from ASGI without out knowledge and whether legal opinion is correct or not is not known by members and Shri Naval Kishore, Elected member also questioned that Cantonment Board has got legal adviser of his own and why legal opinion is taken from Additional Solicitor General of India at Patna High Court and not CBLA to which the PCB replied that the ASGI is a Government of India's counsel and the Competent authority on legal advice as far as Central Government is concerned. PCB told the members if any legal opinion is wrong, the same should be brought before him so that he can peruse the same and if wrong necessary action can be taken.

PCB told a committee constituting Shri Umesh Kumar, Vice President, Shri Ranjeet Kumar Elected Member and Shri Hemant Kumar Singh, Ex-officio Member may be constituted to check the grievances of the Shri Ranjeet Kumar, Elected member along with Shri Nawal Kishor Prasad and if any good improvements can be suggested, the same can be incorporated.
