**LETTER OF M/S HARSH CONSTRUCTION DATED 28.07.2021 SHOWING ITS INABILITY TO CONTINUE WITH THE CONTRACT DUE TO FINANCIAL CONSTRAINTS ON ACCOUNT OF LOCKDOWN IN BIHAR.**

Cantonment Board Office, Danapur Cantt invited the tender reference No. CBD/TS/AC/VE 20-21 and Tender ID 2020\_DGDE\_567209\_1 dated 29.06.2020 "For Awarding the right to collect the License Fee on entry of commercial vehicles at pre-designated entry points in Danapur Cantonment was published e-Procurement system Government of India on 26.06.2020.

Technical bid for the same was opened on 20.07.2020 at 11:30 A.M three bids were received in response to the tender for the work "For Awarding the rights to collect the License Fee on entry of commercial vehicles at the pre-designated entry points Danapur Cantonment"

The Technical Evaluation Committee Recommended that the Financial Bid For Harsh Construction, Vijay Construction and Arya Toll Infra Ltd. can be opened as the technical bids by these tenders opened on 20.07.2020 by technical evaluation committee have been accepted as per the documents submitted by them in the e-tender.

The committee has recommended that the rate of Rs 1,93,51,111/- per annum. "For Awarding rights to collect the License Fee on entry of commercial vehicles at the pre-designated entry points Danapur Cantonment quoted by **HARSH CONSTRUCTION** is reasonable and highest (H1) and order for "For Awarding the rights to collect the License Fee on entry of commercial vehicles at the pre-designated entry points in Danapur Cantonment" was given/awarded to **HARSH CONSTRUCTION (being H1)** and the matter was referred before the board for consideration and approval.


The Board considered and approved the said tender vide Circular Agenda No. 15 dtd. 08.08.2020 and the tender was awarded/given to **HARSH CONSTRUCTION (being H1)** and was referred vide Cantonment Board Office, Danapur Cantt letter No. CBD/TS/AC/VEH/2020-21/724 dtd. 09.09.2020 and was asked to deposit bid amount in installment along with 10% Security Money within stipulated time period.

The firm/Agency was intimated again vide letter No. CBD/TS/AC/VEH/2020-21/02 dtd. 01.01.2021 asking them to deposit the amount within 24 hours after the receipt of the letter.

**HARSH CONSTRUCTION** vide this office various letters No. CBD/TS/AC/VEH/2020-21/09 dtd.21.01.2021; No. CBD/TS/AC/VEH/2020-21/09 dtd.21.01.2021; No. CBD/TS/AC/VEH/2020-21/19 dtd.08.02.2021; No. CBD/TS/AC/VEH/2020-21/96 dtd.06.04.2021; No. CBD/TS/AC/VEH/2020-21/101 dtd.09.04.2021; No. CBD/TS/AC/VEH/2020-21/177 dtd.14.06.2021; No. CBD/TS/AC/VEH/2020-21/175 dtd.23.06.2021; No. CBD/TS/AC/VEH/2020-21/177 dtd.28.06.2021 and No. CBD/TS/AC/VEH/2020-21/187 dtd.05.07.2021 was instructed by this office to deposit security money and rest of the bid amount.

The contractor was asked to deposit the amount of security deposit and also the 1<sup>st</sup> installment of Rs. 8,37,778/-. The contractor deposited the 1<sup>st</sup> installment. Contractor also deposited the 2<sup>nd</sup> installment for Rs. 8,37,778/- in the month of April, 2021. However, the contractor did not deposit other two installments.


The contractor sent a letter stating that the vehicle entry in the cantonment board was reduced considerably due to Covid-19 Pandemic and therefore requested to sympathetically consider its request to enhance the entry of vehicle license fees or to exempt vehicle entry fees for some time. The Cantonment Board however wrote to the Contractor to deposit the balance installment failing which it will take action in terms of the agreement vide its letters dated 09.04.2021, 14.06.2021, 16.06.2021 and 28.06.2021. In response thereof the contractor vide his letter No. 101 dated 30.06.2021 wrote to the Chief Executive Officer of the Cantonment Board stating that due to Covid-19 Pandemic the entry of commercial vehicle in the Cantonment Board Area was reduced and thereafter during the announcement of Lockdown by the State of Bihar the collection of license fees virtually stopped and therefore his financial condition has become bad to worse and he further stated that his collection was only for 15%. Accordingly he requested for grant of extension for the period of at least five months beyond the date of his completion. He had also referred about his huge financial loss due to Lockdown and other reasons mentioned in his aforesaid letter. Thereafter he was further served a letter dated 05.07.2021 for deposition of all the dues. Another letter dated 29.07.2021 was issued to the Contractor in the form of show cause notice that since he has failed in depositing the installment amount which has adversely effected the revenue of the Cantonment Board, thus a proposal for initiating action for his blacklisting is likely to be placed in the meeting

the Cantonment Board wherein action U/S 324 of the Cantonment Act, 2007 will also be initiated against him. Thereafter the contractor sent letter No. 105 dated 28.07.2021 (received via email on 09.08.2021) and legal notice dated 09.08.2021 was served to the Cantonment Board through email on 09.08.2021. In the said letter the contractor has again reiterated the same fact that he has suffered financial loss of Rs. 65,00,000/- due to Covid-19 Lockdown and also due to stoppage of entry of sand loaded commercial vehicles inside the cantonment board area. He also stated that he took loan of Rs. 24,50,000/- from Punjab National Bank, Nawada due to which he has shown his inability to continue with the contract. Accordingly he has requested to foreclose the contract w.e.f. 18.04.2021. In the legal notice served through a lawyer namely Sri Amit Narayan he has again reiterated his problem and has tried to explain the fact that he has suffered loss due to Lockdown imposed in exercise of power under the Disaster Management Act, 2005 and he has taken the plea that his case is covered by clause 9(b) of the Contract Agreement having corresponding terms at Para No. 23 of E-Tender of NIT No. CBD/TS/1. By the said notice it has been requested on his behalf to cancel the contract w.e.f. 18.04.2021 when curfew was imposed. It has also been claimed in the notice that after cancelling the contract, the calculation shall be done to the exact amount on pro-rata on per day basis of total quoted value. He has also requested not to take any legal action against his client.


Legal opinion by Cantonment Board's legal advisor Shri S.D. Sanjay was taken on 10.08.2021 and he has opined that

".....I have perused the file and the letters exchange between the parties. The fact is admitted that the contractor was granted the contract to start the collection on 1<sup>st</sup> January, 2021. After start the work within a month the contractor started making submission that he has losing revenue because of lesser number of vehicle entry in the Cantonment Area. He also deposited only two installments out of four and has deposited a total sum of Rs. 96,76,000/- and was required to deposit the same amount for his contract up to 31.12.2021. However in the intervening period due to the spread of Corona Virus in the 2<sup>nd</sup> wave during March till June 2021 there has been announcement of statutory Lockdown as also night curfew. The Night Curfew was imposed from 18.04.2021 and Statutory Lockdown was imposed from 05 May which continued till 9<sup>th</sup> June, 2021 and thereafter relaxations have been made with certain restrictions.

So far the request of the contractor to foreclose the contract w.e.f. 18.04.2021 is concerned the same cannot be acceded to for the simple reason that even after unlock the contractor has continued to collect license fees till date. However since now fresh tender has been made and the financial bid has been opened which has to be placed before the Board. The conduct of the existing contractor has not been fair and he did not deposit the security amount inspite of repeated request to him, however due to statutory lockdown the contractor can be provided with some benefit of the statutory lockdown as it falls in the category of force majeure.


The contractor has paid two installments for six months period however vide his letter dated 09.08.2021 he has requested for foreclosure of the contract.....

....Thus in my considered opinion and in order to avoid unwarranted litigations and to suffer any further loss it will be in the interest of the Cantonment Board to first finalise the tender with the new bidder who has emerged as H-1 at the earliest and thereafter to foreclose the contract with the contractor namely M/s Harsh Construction. The existing contractor can only be granted extension for the period upto the contract of the new

**Sub: PROVISION OF FUNDS FOR CANTT BOARD EMPLOYEES AS A WELFARE MEASURE-GROUP INSURANCE SCHEME**

Reference: *Principal Director, Defence Estates, Govt. of India, Ministry of Defence, Western Command letter No. 15044/BES/GEN/DE/WC/2020-21 dtd. 19 August, 2021 and Principal Director, Defence Estates, Min. of Defence, Govt. of India, Central Command, Lucknow letter No. 8688/Covid-19/Staff/21/22 dtd. 23 August, 2021 and even letter No. dtd. 25 August, 2021*

Vide above referred letter, Cantonment Board Office, Danapur Cantt has been directed to send the proposal of the proposed employee/contractual staff alongwith consent of the Board with regard to welfare measure for Covid warrior involved in frontline activities and its related work. It was decided that PDDE, WC as Nodal Principal Directorate, in consultation with other PDs DE shall finalize Group Insurance Scheme to provide protective cover to Cantonment Board Employees and relief in case of death to the deceased family.



### SALIENT FEATURES OF THE SCHEME:

- It will cover employees of the Board, both regular & contractual, involved in Covid-19 prevention/related activities.
- Average Premium per beneficiary per annum comes in the range of Rs. 2305/- per person plus GST (i.e. premium for Rs. 5,00,000/-)
- In case of unfortunate death because of any cause (includes disease, infection, accident etc.) the beneficiary family shall get Rs. 5.00 lakh relief.
- LIC shall enter into agreement and furnish group policy to one Cantt Board which shall be designated as Nodal Cantt Board. Here it will be Delhi Cantonment Board.






