It is brought to the notice of the Board that Danapur Cantonment Board Office invited the tender for painting/writing/drawing (Madhubani) on the wall/ceiling of water tower (RCC over head tanks) in Danapur Cantonment area including all required materials(putty/distemper/acrylic emulsion paint etc) and required manpower (painter and helper etc) with necessary scaffolding and safety arrangements vide Tender ID 2022 DGDE 521038 1 dated 29-Apr-2022 and also was published in local newspaper vide office letter No. CBD/JE/Tenders/2022/370 dated 02 May, 2022. Two bidders participated but didn't fulfill the minimum criteria as three bids were not received; where three bids must be received by the office as per criteria.

Further, the same tender was invited vide Tender ID No. 2022_DGDE_530365_1 Dated 11-June-2022. Two bids in respect to this tender received to the office but minimum criteria not fulfilled again, so the same tender had been cancelled and decision to re-invite was taken.

Further, the same tender also invited vide Tender ID No. 2022_DGDE_535871_1 Dated 06-Jul-2022. This office again received two bids in respect to the same tender but it had been found that the bidders didn't fulfill the minimum criteria as per tender terms and conditions. It has been decided again to re-invite the same tender by cancellation of present floating one. The terms and conditions also took some relaxation for finalization of the tender to proceed the work on priority as the time and work of office is being affected due to the running condition in respect to the tender.

Danapur Cantonment Board Office re-invited the tender for painting/writing/drawing (Madhubani) on the wall/ceiling of water tower(RCC over head tanks) in Danapur Cantonment area including all required materials(putty/distemper/acrylic emulsion paint etc) and required manpower (painter and helper etc) with necessary scaffolding and safety arrangements vide Tender ID 2022_DGDE__547999_1 dated 27-Aug-2022.

Technical bid of the same tender was opened by the Technical Committee and found that two bidders submitted their bids against the same tender i.e. (i) Chanda Kumari and (ii) Sunny Engineering and found eligible for the same tender. The technical committee recommended to open the financial bids of bidders and as per recommendation, the financial bids of the bidders have been opened and found that the bid amount of Chanda Kumari is the lowest and coming L1.

In view of the above, the tender for painting/writing/drawing (Madhubani) on the wall/ceiling of water tower (RCC over head tanks) in Danapur Cantonment area including all required materials (putty/distemper/acrylic emulsion paint etc) and required manpower (painter and helper etc) with necessary scaffolding and safety arrangements may be awarded to Chanda Kumari as L1 so that the essential services may not get effected and public interest is upheld.

Subject: VOCATIONAL TRAINING COURSES.

It is to inform that there is a Vocational Training Center running in Danapur Cantonment Board at present which is not operational since Covid-19 outbreak. As per Board's decision vide CBR No. 69 dated 27.08.2022, The center has been renovated and painted. This center is being revamped and four types of vocational training are planned to be organized which include Tailoring, Beautician, English Spoken course and Computer Training.

Certain essential items are needed for the center to ensure the training can be done. Kanhaiya Lal, Storekeeper and Mohammad Naseem, LDA have surveyed the Gems portal for estimation of value of those items. The total estimated cost items come to approx Rs. 5,00,000/-.

All the relevant documents are placed on the table for perusal and consideration of the Board and sanction of the amount. Further, the board can call an expression of interest at reasonable prevalent rates for engaging vocational school Experts / Teachers.
