**REVISION OF THE PAY STRUCTURE OF MEDICAL OFFICER OF CANTONMENT BOARD OFFICE, DANAPUR CANTT**

It is brought to the notice of the Board that one post of Medical Officer in the Cantonment Board Danapur is vacant and needs to be filled up. The current pay scale for the post of Medical Officer is ₹ 4200 as per 6th CPC and Level-6 (35400 – 112400) as per 7th CPC. However, this pay scale is not in accordance with the norms prescribed by the Finance Department, Govt. of Bihar.

As per the Resolution No. 3ए-2-वे0पु0-09/2016.....3590..../वि०, पटना दिनांक 24/05/2017 of Finance Department, Govt. of Bihar, the pay scale for the post of Medical Officer should be ₹ 5400 as per 6th CPC and Level-9 (53100 – 167800) as per 7th CPC. This pay scale is also applicable to the similar post in this establishment as per the Existing pay scales (6th CPC) and corresponding Pay Levels (7th CPC).


Therefore, it is proposed that the pay scale and pay structure for the post of Medical Officer in the Cantonment Board Danapur be revised as per the above-mentioned norms and documents. The revised pay scale will be effective from the date of filling up of the post.

The financial implication for revising the pay scale for the post of Medical Officer will be ₹ 2,50,000.00 (₹ Two Lacs Fifty Thousand) per annum. This amount will be met from the budgetary allocation of the Cantonment Board Danapur.

The file containing all the relevant documents/papers is placed before the Board for its consideration and approval.

**RESOLUTION:** The Board considered the matter and resolved to revise the Grade Pay for the Medical Officer in accordance with norms prescribed by the Finance Department, Govt. of Bihar. The current Pay Scale for the post of Medical Officer is ₹4200 as per 6th CPC and Level-6(35400-112400) as per 7th CPC but the pay Scale for the same post should be ₹ 5400 as per 6th CPC and Level-9 (53100-167800) as per 7th CPC.

Further, the Board resolved to forward the proposal to Directorate for approval of the pay scale and pay structure for the post of Medical Officer.

**INCREASE OF DA BY 4% (INCREASE FROM 38% TO 42%) FOR CANTONMENT BOARD EMPLOYEES & PENSIONERS AS PER 7<sup>TH</sup> CPC: THE PROPOSAL HAS TO BE FORWARDED TO PDDE, CC, LUCKNOW FOR SANCTION**

It is brought to the notice of the Board that the State Government of Bihar has increased the rates of DA by 4% w.e.f. 1<sup>st</sup> January 2023 from 38% to 42% for employees and pensioners vide Govt. order of Bihar State Govt. Resolution No. संख्या 3ए-3-भत्ता-01/2022-3353/वि० पटना, दिनांक 11/04/2023 एवं संख्या 3ए-3-भत्ता-01/2022-3352/वि० पटना, दिनांक 11/04/2023. As per clause-14 of the memorandum of settlement the Cantonment Board Employees and pensioners are entitled to DA at par with the State Govt. in which a Cantonment is situated. Hence the said increase of DA is applicable to the employees and pensioners of the Danapur, Cantonment Board. The increased DA can be paid to these employees and pensioners after obtaining the necessary approval of the Board and sanction of the GOC-in-C/principal Director, Defence Estates, Central Command, Lucknow.

All the relevant documents/papers are placed on the table before the Board for perusal. The Board may consider and approve the same.

All the five bidders found eligible to participate in this eAuction for license for collection of parking on parking of Tempo, Taxi, Jeep and E-Rickshaw in cantt area, Danapur Cantt and they were allowed to participate in this eAuction as per eligibility and proper documents/papers produced by the bidders. Thereafter, the technical committee recommended to allow all the bidders i.e. (i) Rishikesh Kumar (ii) Shiv Manyu Kumar (iii) Rajesh kumar (iv) Rabindra prasad and (v) Nazir prasad to participate in this Auction.

All the above-recommended bidders (i) Rishikesh Kumar (ii) Shiv Manyu Kumar (iii) Rajesh kumar (iv) Rabindra prasad (v) Nazir prasad participated in this Auction for license for collection of parking on parking of Tempo, Taxi, Jeep and E-Rickshaw in cantt area, Danapur Cantt but Sh. Rishikesh Kumar mounted the highest bid i.e. ₹ 2,51,00,000.00 (₹ Two Crore Fifty-One Lacs) and became the highest bidder among them. Sh. Nazir Prasad mounted the second highest bid i.e. ₹

2,50,00,000.00 (₹ Two Crore Fifty Lacs) and became the second highest bidder in this Auction for collection of parking on parking of Tempo, Taxi, Jeep and E-Rickshaw in cantt area, Danapur Cantt.

The contractor was called vide File No. CBD/TS/Contract/2023-24/Tempoo-Taxi/196 dated 13/03/2023 to deposit 10% i.e. ₹25,10,000.00(₹Twenty Lacs and Ten Thousand) of the highest bid amount as security money and 50% ₹ 1,25,50,000.00(₹ One Crore Twenty-Five Lacs and Fifty Thousand) of the highest bid amount. Thus, the contractor was required to deposit a total amount ₹1,50,60,000.00 (₹ One Crore Fifty Lacs and Sixty Thousand). In response to the same, the Contractor visited this office and requested for providing time a period of one week to deposit the amount.

Further, it is brought to the notice of the Board that in continuation, the contractor refused to deposit the requisite amount as asked vide the above-mentioned letters. Thereafter, Danapur Cantonment Board sought legal opinion in the interest of the Board from the Legal Advisor of the Cantonment Board w.r.t. the matter and the legal advisor advised that "It is imperative that M/s. Sri Balaji Iron and its proprietor Mr. Rishikesh Kumar are liable not only to be blacklisted by the Board under notice to them in writing but also are also jointly and severally liable to be legally prosecuted by the Board in order to recover from them the amount of loss sustained due to the irresponsible and illegal acts of the highest bidder. Opined accordingly".

Subsequently, as per the recommendation of the committee in the interest of the Board, Danapur Cantonment Board invited eAuction again through proper channel for "parking fee on parking of Tempo, Taxi, Jeep and Erickshaw" in Cantonment area, Danapur on 05.04.2023. No bidder participated in this eAuction.

Looking at the matter concerning of revenue to the Board, the auction committee recommended to re-invite for the same. Danapur Cantonment Board re-invited auction on 18.04.2023 and again no bidder participated in this eAuction.

In view of the above, the acution committee recommended again to invite for the same. As per recommendation, Danapur Cantonment Board invited auction on 27.04.2023 and again no bidder participated.

It is further brought to the notice of the Board that taking the matter on a priority concerned to the revenue of the Board, it was decided that a fresh survey is required to hold to estimate the cost of Auction and vide Daily Order Part II No. 35 dated 03.05.2023, a survey committee was constituted and the committee held a survey from 06.05.2023 to 08.05.2023 and a review survey from 09.05.2023 to 11.05.2023. During the survey, it was found that total nos. 1430 tempo and 632 eRickshaw are plying everyday in the Cantonment area. The committee calculated yearly amount according to the approved rate and on calculation, it has been observed that 1,81,43,600.00(One Crore Eighty One Lacs Forty-Three Thousand and Six Hundred) per annum can be a fair benchmark to initiate the eauction based bidding.

Keeping every aspects of the auction points comprising calculations as discussed above, the committee recommended again to re-invite and the same was re-invited on 17.05.2023 vide eAuction ID 2023\_MoD\_2506 dated 16.05.2023. The details are mentioned hereunder:

Rajesh Kumar, S/o Kapildeo Prasad, Saguna, Naya Toal, near Durga Mandir, Danapur, Patna mounted the highest bid amount ₹ 1,90,10,000.00 (One Crore Ninety Lacs and Ten Thousand) and became the highest bidder(H1). Sh. Nazir Prasad, S/o Sugamber Prasad, Digha Ghat, Patna mounted bid amount ₹ 1,90,05,000.00 (One Crore Ninety Lacs and Five Thousand) and became the second highest bidder.

Thereafter, numerous representations were received from Sh. Shivmanyu Kumar were received by this office that he is ready to take the same auction at an amount of ₹1,95,00,000.00 (One Crore Ninety-Five Lacs) and that due to technical glitches he was unable to participate.

As per the applications submitted by Sh. Shivmanyu Kumar and the matter concerning the revenue to the Board, the committee recommended again to re-auction to get the highest amount in the interest of the Board. Danapur Cantonment Board invited the auction again which details are hereunder:

The Technical Bid was opened on 03.03.2023 and three bids received in response to the eAuction ID 2023\_Mod\_2355.

All three bidders are found eligible to participate in this auction for "License for Road Side Hawking fee in the Cantonment area, Danapur Cantt and they participated in this auction as per eligibility and proper documents/papers produced by the bidders. Thereafter, the technical committee recommended to allow all the bidders to participate in this auction but no bidder participated in the auction.

Further, the committee recommended to re-invite the same and Danapur Cantonment Board invited the auction again on 22.02.2023 and it was found that no bidder participated.

Subsequently, as per the recommendation of the committee in the interest of the Board, Danapur Cantonment Board invited auction on 21.03.2023. On the opening of the technical bid, it was found that no bidder participated in this eAuction.

Looking at the matter of revenue to the Board, the auction committee recommended to re-invite the auction and Danapur Cantonment Board re-invited on 05.04.2023 and again no bidder participated.

In view of the above, the committee recommended again to invite the auction for the same. As per recommendation, Danapur Cantonment Board invited auction on 18.04.2023 and again no bidder participated.

Thereafter, the same was re-invited again on 27.04.2023 as per the recommendation of the committee but no bidder participated again.

It is further brought to the notice of the Board that taking the matter on a priority concerned to the revenue of the Board, it was decided that a fresh survey is required to estimate the cost of initiating the e-auction and vide Daily Order Part II No. 34 dated 03.05.2023, a survey committee was constituted and the committee held survey from 03.05.2023 to 04.05.2023. During the survey, it was found that total nos. 532 are conducting hawking everyday in Cantonment area. The committee calculated yearly amount according to the approved rate and on calculation, it has been observed that 42,00,000.00(₹ Forty-Two Lacs) per annum can be a fair benchmark to initiate the e-auction based bidding.

Keeping every aspects of the auction points comprising calculations as shown above, the committee recommended again to re-invite the auction and the same was re-invited on 17.05.2023 vide eAuction ID 2023\_MoD\_2504 dated 16.05.2023. The details is mentioned hereunder:

Total performed period amount of Rs. 44,44,420/- (Forty four Lacs Forty Four Thousand Four Hundred and Twenty) only may be deducted from the deposited amount and the rest amount may be refunded to the contractor M/s Vijay Construction.
