TENDER FOR REPAIR & MAINTENANCE OF SARAI KI MASJID ROAD FROM RESIDENCE OF RAM BABU SETH TO MARSHALL BAZAR-BIBIGANJ CORNER AND AT THE BACK OF CIVIL HOSPITAL FROM CORNER OF THE HOSPITAL TO LALKOTHI MASJID, WARD NO.4

It is brought to the notice of the Board that the subject tender namely 'Repair & Maintenance of Sarai ki Masjid Road from residence of Ram Babu Seth to Marshall Bazar-Bibiganj corner and at the back of Civil Hospital from corner of the Hospital to Lalkothi Masjid, Ward No.4' was floated on 25.01.2024 on CPPP. It is noted that the same tender was floated two times earlier too.

For the 1st time, the subject tender was invited on 23.12.2023, only one technical bid was found on due date. Hence for 2nd time, the same tender was re-invited on 15.01.2024 and opened on the due date, only one technical bid was found.

Hence the subject tender has been re-invited for the 3rd time on 25.01.2024 through e-tendering process vide Tender ID 2023_DGDE_639077_1 dated 25.01.2024. In response to the above publication, after opening of the tender on the due date, one bid was found.

The rate quoted by the bidder with details of the same are mentioned hereunder:

The bid amounting to ₹28,37,400/- quoted by Sanjay Kumar, Bibiganj, Danapur Cantt, Patna – 801 503 as compared to the estimated cost of ₹28,76,910/- is found reasonable.

REMOVAL OF TIN SHOP NO-4B ALONG WITH WAIVE OFF IT'S RENT.

It is brought to the notice of the Board that the tin shop No-4 at Bus Stand, Danapur Cantt was divided into three parts 4, 4A and 4B in 1995. The parts 4 and 4A are still rented and running but the part 4B is shut down and deserted. The condition of part 4B is poor and unsafe. This shop has been inactive for a long time. The renter/lessee of this tin shop no. has not been in touch with this office for a long time. This office has sent notices and bills to this shop number but has not received any reply. Notices and bills were also pasted against this tin shop number. This tin shop is also causing a hindrance as it is situated in the middle of the other shops. The rent due for this shop number is Rs.1,67,791/- till February 2024.

Hence, it is suggested that this shop number be cancelled and the rent due for this tin shop number be waived off.


