Enterprises, 1st floor, 515/3130, Gujarat Housing Board, B/h, Police Station, Bapunagar, Ahmedabad, Gujrat – 380 024 had been communicated many times to produce all the requisite documents/papers related to EPF and ESIC but they failed to do so and the said firm is continuously ignoring the letters whereas the concerned matter is most important in the interest of contractual employees who are working in the Cantonment Board, Danapur.

As per direction of the Labour Enforcement Officer during the inspection, the firm was also served a final reminder in this respect but neither documents/papers had been produced nor any reply/information from the side of the firm had been submitted. It has been found that the earlier report regarding EPF and ESIC, submitted by the firm is not matching with the record of individuals. This lackadaisical behaviour of the firm depicts that no interest is being shown in the welfare of contractual employees.

In view of the above, this office has reached on the conclusion to blacklist/debar the firm i.e. H.R. Enterprises, 1st floor, 515/3130, Gujarat Housing Board, B/h, Police Station, Bapunagar, Ahmedabad, Gujrat – 380 024 for future tender of this office.
