SETTLEMENT OF PROPERTY TAX W.R.T. HIRED BUILDINGS/ BUNGLOWS.

It is brought to the notice of the Board that the officials of this office found from the office records that there are total 29 hired buildings/bunglows available in Danapur Cantonment and a huge amount on account of property tax and water rate are due on those 29 nos of hired buildings/bunglows since last couple of decades and the test audit team has also raised objection on these huge dues amounts w.r.t. property tax and water rate. The matter is taken seriously and this office has started survey of all the 29 properties situated in Danapur Cantonment to know about the present status of the properties and the officials of this office found that the some of the buildings are in dilapidated conditions and some of the properties are in the use of army for their officers/officials residents and for office also.

After completion of survey of the properties the detailed report of the present status of the properties with photographs are sent to the local military authorities i.e. Adm. Comdt., Stn HQ Cell Danapur Cantt and to the DEO, Danapur Cantt vide this office letter No. CBD/TS/Hired Buildings/2024/366 dated 29.07.2024 to confirm the present status of the said properties. The Adm. Comdt., Stn HQ Cell Danapur Cantt replied vide their letter No. 167503/23/Q2(OGB) dated 26.11.2024 and the DEO Danapur forwarded a list of hired buildings/bunglows with present status of the properties vide their letter No. D-22/DNR dated 19.11.2024 which is mentioned hereunder for the ready reference of the Board: -

Now, it can be concluded from the, correspondences with LMA Danapur and the DEO, Danapur that the above hired buildings/bunglows are presently situated on defence land in the army area and most of the buildings are in use of army and MoD are paying service charges annualy for A1 defence land to the Danapur Cantonment Board, it is not feasible to charge property tax on said A1 defence land properties and also from the abandon and dilapidated properties in Cantonment area. The liabilities of above properties is attached as Annexre 'A'.

In this situation it is required to sent a proposal to the higher authorities under section 115 of the Cantonment Act 2006 with the permission of the Board for settlement of the dues amount w.r.t. property tax above than ₹2,500/- and property tax upto ₹2,500/- can be settled through Cantt Board as per above mentioned rule and since the water rate is imposed by the Cantt Board it can also be settled through the Board as per rule.

The file containing all the connected document are placed on the table for perusal and consideration of the Board. The Board may consider the same.

RESOLUTION: The Board discussed the matter at length and decided to forward the proposal of the properties whose demand is more than 2500/-(Two Thousand Five Hundred) in case of property taxes and for the rest the Board will take action in due course.

Thereafter the property came in possession of Ramesh Kumar vide Title Partition Suit No.106/2014.

Further, it is to submit that this office has issued a public notice vide this office letter No. CBD/H.No.2 3 41 42, M.No.2, W.No.4/944 dated 7th December 2020, calling for objections (if any) from the public regarding the proposed mutation of the aforementioned holdings in the name of Sri Ramesh Kumar S/o Late Ram Janki Sharan. This notice was published in the newspapers 'The Telegraph' and 'Dainik Bhaskar'. No objections were received within the stipulated period.
