DEVELOPMENT OF VENDING ZONE IN DANAPUR CANTONMENT AREA

Reference: Circular Agenda No. 28 dated 21.02.2024 apprved vide CBR No. 84 Dated 12 March 2024 and PDDE, CC, Lucknow letter No. 51569/DNR/Cantt/R.K./V/23 dated 02 June 2025

It is brought to the notice of the Board that the Principal Director, Defence Estates, Government of India, Ministry of Defence has accorded the sanction for development of vending zone Danapur Cantonment Area vide PDDE. CC. Lucknow letter No. 51569/DNR/Cantt/R.K./V/23 dated 02 June 2025.

Further, it is brought that the Danapur Cantonment Board has oserved the following key points on top priority before arrangement of vending zone in Danapur Cantonment area:

- 1. In accordance with Street Vendors (Protection of Livelihood and Regulation of Street Vending) Scheme – 2014, a vending zone after successful completion of survey of street vendors who are coming since a long time is being arranged.
- 2. The Danapur Cantonment Board recognized an appropriate location and land under its management for the orderly arrangement of street vendors within the Danapur Cantonment area. These arrangements will be purely temporary and implemented on land managed by the Danapur Cantonment Board. No Government interest or Defence land shall be compromised in any manner.

- 3. This initiative is being undertaken in the public interest to alleviate traffic congestion and ensure unobstructed movement for commuters, ambulances, and other emergency vehicles.
- 4. No money from the department i.e. Cantonment Board, Danapur is being spent and the Vendors voluntarily paid the money for Carts directly to the agency concerned.
- 5. The Cantonment Board, in coordination with the Town Vending Committee, will determine a suitable fee structure in the Board's interest. An agreement detailing terms and conditions will be established to safeguared the Board's interests.
- 6. Vendors will be allocated spaces for an initial one-year period purely on a temporary basis. subject to clearance, if necessary, which can be extended for the further year on consideration of the situation.
- 7. The Danapur Cantonment Board or the Chief Executive Officer reserves the right to modify the prescribed terms and conditions or introduce additional provisions in accordance with situational requirements.
- 8. "Under no circumstances shall any rule, term, condition, or provision of the Cantonments Act, 2006 be compromised. The Board and the Chief Executive Officer reserve the right to take appropriate action in such cases."
- 9. The vendors shall be bound by all rules, regulations, terms, and conditions as framed from time to time by the Board and/or Chief Executive Officer, as well as by any instructions or directions issued by the competent authority. They shall comply with each provision of the Cantonments Act, 2006.
- 10. No vending is allowed except the earmarked vending zone.

All the relevant documents/papers are placed on the table before the Board for perusal. The Board may consider and approve the same.

RESOLUTION: The Board discussed the matter at length and approved accordingly. Further the Board directed to take further suitable process to set up the vending zone within the jurisdiction of Danapur Cantonment Board as per extant rules, provisions and Act in public interest.

BUILDING BYE-LAWS OF DANAPUR CANTONMENT

Reference: Directorate General, Defence Estates, Govt. of India, Ministry of Defence, Raksha Sampada Bhawan, Delhi Cantt letter No.12/1/Building Bye-laws/Gen/C/DE/2022 Vol-III PC (FMS 80429) dated 31.01.2025

It is brought to the notice of the Board that the Ministry of Defence, through their letter under reference, has conveyed a draft model framework intended for the formulation of Building Bye-laws. This framework is accompanied by exhaustive instructions and guidelines to assist in its drafting. Pursuant to these directions, the Directorate has mandated this office to appoint a qualified expert agency for the specific purpose of framing the Building Bye-laws applicable to Danapur Cantonment.

The formulation process entails a thorough evaluation of parameters uniquely relevant to the geographical and infrastructural context of the Cantonment. These parameters are to be derived from the findings and recommendations presented in the TERI report and are expected to include among other technical factors- the Floor Space Index (FSI) algorithm. The culmination of this exercise is to be the preparation of a comprehensive final draft of the proposed Building Bye-laws.

In compliance with the aforesaid directive, this office formally approached the Director, The Indian Institute of Technology, Patna, requesting their assistance in drafting the required Building Byelaws for Danapur Cantonment. The Institute has submitted the completed draft in response vide their letter dated 28.06.2025, which is attached herewith.

The relevant case files, including the draft Building Bye-laws prepared for Danapur Cantonment in collaboration with IIT, Patna and all concerned documents, are hereby placed before the Board for perusal, consideration, and necessary approval so that it can be forwarded to the higher authorities for further necessary action.

RESOLUTION: The Board discussed the matter at length, approved the draft bye-laws and recommended to forward the same to the Higher Authority for necessary action.

<u>PUBLICATION OF BOOK NAMELY 'THE MAKING OF THE FIRST CANTONMENT</u> <u>OF THE INDIAN SUBCONTINENT IN PATNA, 1757-1768'</u>

It is brought to the notice of the Board that the Danapur Cantonment, recognized as the oldest cantonment in the Indian subcontinent, has surpassed 250 years since its establishment. Historical records indicate that on August 5, 1765, the barracks at Bankipur were officially elevated to Cantonment as per the instruction of Robert Clive, the then Governor of Bengal. After the devastating fire in the

barracks of Bankipore Cantonment in March and May'1767, the Danapur Cantonment was relocated westward to Danapur in 1767 and 1768 respectively, where it continues to exist.

This historical narrative is based on extensive research conducted by the esteemed scholar, historian, and author Prabuddha Biswas. His book, 'The Making of the First Cantonment of the Indian Sub-continent in Patna, 1757-1768', provides a detailed account of the establishment and development of the Danapur Cantonment, confirming its position as the oldest Cantonment in the Indian Sub-continent.

Considering the historical importance of this documentation, it is essential that the book receives widespread publicity. Accordingly, this office intends to take the requisite measures to support its publication and broader distribution.

The total publication cost for 200 books amounts to ₹2,40,000/-, with each book priced at ₹1200/-. Each volume consists of 384 pages printed in single colour on Maplitho paper, along with 56 pages in multicolor on Art paper, all bound in a durable hard cover.

All the relevant documents and estimates are placed on the table for perusal and consideration of the Board.

RESOLUTION: The Board discussed the matter at length; elaborated in detail and approved the expenditure to publish the books.
