## ENGAGEMENT OF CHARTERED ACCOUNTANT AS CANTT BOARD REPRESENTATIVE FOR HANDLING ACCRUAL BASED ACCOUNTING SYSTEM (ABAS)

Reference: CBR No. 09 dated 27.08.2024

It is brought to the notice of the Board that vide CBR No.09 dated 27.08.2024, M/s Saba & Co.
